

Instruction on Real Account Opening

Step 1

Get yourself acquainted with the information posted on the Company's website (Customer Agreement, Trading Terms, Confirmation of Legal Origin of Funds) and confirm that you have read the terms and conditions, that you understand them and that you agree to be bound by them.

Browse the copy(ies) of your identity documents (JPG, PNG or GIF formats) and tick "I confirm the legal origin of funds". If you are unable to browse a copy of your identification form, tick " I will send the copy(ies) of my documents to info(at)realtrader.org or fax it at 0037052313113" and then confirm the legal origin of funds.

Confirmation of Legal Origin of Funds

Herewith I certify that the funds coming to the account are of legal origin. Account and services provided by the Company shall not be used for any illegal purpose. I also undertake to accomplish no activity/transaction for the purpose of laundering of proceeds derived from criminal activity and financing of terrorism. On request of the Company's employees I undertake to provide the documents confirming the lawful source of funds.

Identification of the Client

To comply with the client identification and verification requirements, Real Trade Corp. is required to obtain, verify, and record information that identifies each person who opens an account.

Acceptable Identity Documents:

- Passport
- Driver's License
- National Identity Card

An acceptable document must be current (not expired).

Note: In accordance with anti-money laundering regulations, all withdrawals will be sent in the name of the account holder.

Attention: Your trading account will be activated only after a valid copy of identity document is received.
